## 'अक्तूबर तक पूरा होगा पंजाबी बाग राजा गार्डन फ्लाईओवर का काम'

जनसत्ता सवाददाता नई दिल्ली, 19 मई।

दिल्ली की लोक निर्माण विभाग (पीडब्लूडी) मंत्री आतिशी ने शुक्रवार को अधिकारियों को पंजाबी बाग और राजा गार्डन के बीच किए जा रहे फ्लाईओवर के निर्माण में तेजी लाने और यात्रियों को असुविधा से बचाने के लिए इसे दिसंबर की बजाय अक्तूबर तक पूरा कर लेने का निर्देश

उल्लेखनीय है कि फ्लाईओवर के निर्माण को पूरा करने की समय सीमा दिसंबर तक है और एक बयान के अनुसार, पीडब्लूडी ने इसका



50 फीसद काम पूरा कर लिया है। मंत्री ने परियोजनाओं का निरीक्षण करने के बाद कहा कि नए फ्लाईओवर से रिंग रोड पर यातायात का दबाव काफी कम हो जाएगा। बयान में कहा गया है कि उन्होंने अधिकारियों को निर्माण में तेजी लाने और यात्रियों को किसी भी तरह की असुविधा को खत्म करने के मद्देनजर इसे दिसंबर के बजाय अक्तूबर तक परा कर लेने का निर्देश दिया। आतिशी ने कहा कि पीडब्लुडी और हमारे इंजीनियर चौबीसों घंटे काम कर रहे हैं, ताकि न केवल दिल्ली की सड़कों को सुंदर

बनाया जा सके. बल्कि यातायात का दबाव कम करने के लिए उनका विस्तार भी किया जा सके। इस संबंध में, फ्लाईओवर का दोहरीकरण और पंजाबी बाग में विस्तार मौजूदा सड़कों पर यातायात के दबाव को कम करने और दिल्ली की प्रगति में योगदान देने में महत्वपूर्ण साबित होगा।

# मंत्री ने अधिकारी से की बदसलूकी

सेवा का अधिकार दिल्ली सरकार को मिलने के बाद उपराज्यपाल और मुख्यमंत्री के बीच एक बार फिर से टकराव शुरू हो गया है। शुक्रवार को उपराज्यपाल वीके सक्सेना ने मुख्यमंत्री अरविंद केजरीवाल को एक पांच पेज की चिट्ठी लिखी है और चिट्ठी में दिल्ली सरकार के मंत्री सौरभ भारद्वाज द्वारा आइएएस अधिकारी के साथ किए गए दुर्व्यवहार पर चिंता जाहिर की है। मामले में उपराज्यपाल ने मुख्यमंत्री को मामले में ठोस कार्रवाई सुनिश्चित करने को कहा है और बिगड़ी प्रशासनिक व्यवस्था पर भी सवाल उठाया है।

यह मामला सेवा विभाग के सचिव आशीष मोरे की शिकायत के बाद सामने आया है। इस मामले में आशीष मोरे ने एक शिकायत मुख्य सचिव को भेजी थी और मंत्री सौरभ भारहाज हारा किए गए गलत व्यवहार का मामला उठाया था। शिकायत में कहा गया था कि सौरभ भारद्वाज ने तबादले संबंधित कागजातों पर उन पर जबरन हस्ताक्षर करने का दबाव बनाया था। पत्र में उपराज्यपाल ने कहा कि 11 मई 2023 को सर्वोच्च अदालत के निर्णय के बाद ऐसा व्यवहार सामने आया है। उन्होंने चिट्ठी में सौरभ भारद्वाज के उन शब्दों को भी लिखा है ( मंत्री ने अधिकारी को कहा है कि साइन कर, ऐसे कैसे साइन नहीं करेगा। तेरे को तो करना ही पड़ेगा। इसके बाद तेरा भविष्य खत्म। तेरी तो जिंदगी बर्बाद करके रहंगा। इस दिल्ली, चिराग दिल्ली का रहने वाला हं)

इसके अतिरिक्त एक अन्य महिला आइएएस अधिकारी की उपस्थित में मंत्री ने कहा कि तुम दोनों का भविष्य अब खत्म है, तुम लोग चुने हुए प्रतिनिधियों की बात नहीं सुनते हो। मुख्य सचिव के बहकावे में आकर चुनी हुई सरकार से पंगा ले रहे हो। मैं अभी देखता हूं आगे तुम लोग नौकरी कैसे करते हो। तुम्हारी नौकरी जाएगी और बाद में नौकरी बचाने के लिए तुमको मेरे ही पास आना होगा। तब देखूंगा तुम दोनों को।

उपराज्यपाल ने कहा है कि बड़े अधिकारों के साथ बड़ी जिम्मेदारियां भी आती हैं। यह दुर्भाग्यवश है कि अदालत के आदेश के तत्काल बाद ही इस तरह के आदेश जारी कर रहे हैं। जो कि प्रशासनिक तौर पर सिविल सर्विस बोर्ड (सीएसबी) के दायरे में आता है। इस मामले में सर्वोच्च न्यायालय द्वारा ही 2013 में आदेश जारी किए गए थे। जो सीधे तौर पर अदालत क आदेशों का उल्लंघन है। उपराज्यपाल ने कहा है कि उनके पत्र को सही दिशा में लिया जाए और इस

## मंत्री सौरभ भारद्वाज का आरोप, मुख्य सचिव ने दी जान से मारने की धमकी

दिल्ली के सेवा मंत्री सौरभ भारद्वाज ने शुक्रवार को मुख्य सचिव नरेश कुमार पर उन्हें जान से मारने की धमकी देने का आरोप लगाया और कहा कि उन्होंने इस मामले से उपराज्यपाल वीके सक्सेना को अवगत करा दिया है।

भारद्वाज का यह बयान दिल्ली में आम आदमी पार्टी नीत सरकार और नौकरशाहों के बीच बढते गतिरोध के मध्य आया है। उपराज्यपाल सक्सेना से राजनिवास में भेंट के बाद भारद्वाज ने संवाददाताओं से कहा कि उपराज्यपाल ने उन्हें कार्रवाई का आश्वासन दिया है। मंत्री ने कहा कि 16 मई को लोक सेवा बोर्ड की बैठक होनी थी और हम सभी रात साढे नौ बजे तक मुख्य सचिव का इंतजार कर रहे थे, क्योंकि वह व्यस्त थे। हमने उन्हें वाट्सऐप पर संदेश भेजा और उन्होंने कहा कि वह आएंगे।

भारद्वाज ने आरोप लगाया कि 'रात साढे नौ बजे जब वह मेरे कार्यालय में आए तो उन्होंने मुझे जान से मारने की धमकी दी।' उन्होंने कहा कि हमने उपराज्यपाल महोदय को स्पष्ट शब्दों में इस बारे में अवगत करा दिया है। उन्होंने कहा है कि वह सख्त कार्रवाई करेंगे।

## गरीब वर्ग को शिक्षा से वंचित करने से फैलती है घृणा: सिसोदिया

दिल्ली के पूर्व उपमुख्यमंत्री मनीष सिसोदिया ने तिहाड़ जेल से एक पत्र लिखकर शिक्षा की क्रांतिकारी शक्ति तथा समाज के वंचित वर्गों के उत्थान की आवश्यकता पर जोर दिया। मुख्यमंत्री अरविंद केजरीवाल ने ट्विटर पर यह पत्र साझा किया है। सिसोदिया ने अपने पत्र में प्रत्येक बच्चे को उनकी सामाजिक-आर्थिक पृष्ठभिम पर ध्यान दिए बगैर समान अवसर उपलब्ध कराने तथा शिक्षा तक पहुंच की तत्काल आवश्यकता पर जोर दिया।

पूर्व शिक्षा मंत्री ने समाज के वंचित वर्ग के बच्चों की शिक्षा को नजरअंदाज करने के परिणामों पर गौर करने का आग्रह किया। उन्होंने कहा कि गरीब वर्ग को शिक्षा से वंचित करना न केवल असमानता कायम रखता है बल्कि यह नफरत और घृणा भी फैलाता है। उन्होंने पत्र में सत्ता और राजनेताओं पर कटाक्ष करते हुए कहा कि अगर हर गरीब को मिली किताब, तो नफरत की आंधी कौन फैलाएगा? सबके हाथों को मिल गया काम तो सड़कों पर तलवार कौन लहराएगा? उन्होंने लिखा- अगर हर किसी को मिल गई अच्छी शिक्षा तो इनका 'वाट्सऐप विश्वविद्यालय' बंद हो जाएगा। पढ़े-लिखे और समझदारी की बुनियाद पर खड़े समाज को, कोई कैसे नफरत के मायाजाल में

सुरक्षा के पर्याप्त इंतजाम किए जाएंगे और प्रदर्शन स्थल पर पहले से ही बहुस्तरीय अवरोधक लगा दिए गए हैं। एक अन्य अधिकारी ने कहा कि दिल्ली के सीमावर्ती इलाकों में भी पिकेट लगाकर जांच बढ़ाई जाएगी। उन्होंने कहा कि जरूरत पड़ी तो और दिल्ली की सीमाओं पर भी गश्त बढाई जाएगी। प्रदर्शनकारी पहलवानों को सलाह देने वाली 31 सदस्यीय समिति ने सात मई को कहा था कि अगर भारतीय कुश्ती महासंघ के प्रमुख बुजभूषण शरण सिंह को 21 मई तक गिरफ्तार नहीं किया जाता है, तो वह एक महत्वपूर्ण निर्णय लेगी। सात मई को भारतीय किसान युनियन (भाकिय्) के प्रवक्ता राकेश टिकैत, खाप महम 24 के प्रमुख मेहर सिंह और संयुक्त किसान मोर्चा के नेता बलदेव सिंह सिरसा ने प्रदर्शनकारी पहलवानों के साथ मंच साझा किया था।
